Attached you will find a copy of the 2017 Pool Registration Form. All residents must fill out the form and send back to receive pool passes for this year. Please note that passes will only be permitted to account holders in good standing. A member in good standing means all Association fees, fines, and late fees are paid in full.

The number of passes received is based on the number of bedrooms in a Unit. A Unit with 2-bedrooms will receive a maximum of four (4) passes. A Unit with 3-bedrooms will receive a maximum of six (6) passes. Anyone using a pass must abide by the pool Rules of Conduct.

Once the form is received and processed, Pool Tags will be issued. A copy of the Rules of Conduct will be sent as well.
