Dear Putnam Village Homeowner,

We are pleased to announce the pool will be opening on Monday, June 14th, 2021. The Putnam Village Board and Management have worked closely with Danbury Village to ensure your enjoyment of the pool this summer. The pool will be open every day from 12PM to 8PM. There will be an hour break from 4PM to 5PM each day for sanitization where all residents must leave the pool area.

In these challenging and unprecedented times, we need to do everything we possibly can to keep the Community safe. The delay in opening was due to development of mandatory additional guidelines that will help ensure we follow CDC regulations on pools. To facilitate these additional procedures, we had to hire an extra employee every day through our pool company.

Attached you will find a copy of the updated mandatory guidelines for the Putnam/Danbury pool this summer in addition to our regular pool rules. If you would like to visit the pool this season, please fill out the attached pool form in entirety and sign the attached liability waiver. Pool passes will be distributed for members of the Putnam Village household only that are listed on the pool form. The liability waiver must include any minor children of the household.

These additional measures are for the protection of the entire Community and are subject to change based on CDC guidelines and increases in COVID-19 statistics within the area.

MANDATORY GUIDELINES TO BE IN COMPLIANCE WITH CDC RECOMMENDATIONS

- Pool form and waiver & release of liability form must be completely filled out by residents over the age of 18, signed and returned to Management Office before pool tags will be issued
- The delayed opening date will be Monday, June 14, 2021
- Pool days will Monday through Sunday, from 12PM to 8PM
- There will be a 1-hour break from 4 to 5PM when everyone must exit the pool area to stagger residents attending the pool and for the lifeguard and gate worker to sanitize the area
- Limit of 30 residents at one time
- One extra gate worker will be hired by IM Pools to monitor the number of residents, sanitize bathrooms and handrails regularly and encourage the use of masks
- Masks highly recommended by anyone over 2 years old while not in the pool
- No guests or visitors are allowed. Only Putnam or Danbury residents
- No chairs or tables will be provided. Residents may bring their own chairs and/or towels.
- Social distancing of non-family members will be maintained at 6 ft in and out of the pool
- Children under 18 must be accompanied by a parent or legal guardian
- All adults must bring ID to show they are Putnam/Danbury residents
- No eating or drinking at the pool
- Limit 1 person in the bathroom area at a time except for family members
- If residents are not adhering to these rules or there is a spike in COVID cases, we reserve the right to shut the pool down

GENERAL RULES OF CONDUCT FOR THE POOL

- No one may be in the pool unless the pool is attended by the lifeguard.
- No pets are permitted in the pool area.
- Radios may be played at a moderately low volume or with the use of earphones.
- **NOT PERMITTED IN THE POOL OR POOL AREA**: Running, ball playing, horseplay, dunking, diving and excessive splashing.



- Proper bathing attire must be worn. No cut-offs, shorts or pants will be permitted in the pool.
- Use of special equipment such as masks, fins, snorkels, and floats may be used only with the lifeguard's permission and may be prohibited at his/her discretion. This equipment may **NOT** be stored in the pool area and must be taken home every evening.
- **SMOKING IS NOT PERMITTED** in the pool area.
- Children
 - o Only special "swim" diapers are permitted to be worn in the pool.
 - o Children must be accompanied by a parent or legal guardian
- The lifeguard is in charge of the pool area and responsible for the operation of the swimming pool and may prohibit any person who violates these regulations from using the pool or the pool area.
- When it is necessary for the lifeguard to order anyone to leave the pool or pool area, the lifeguard shall make a written report to the Board of Directors. Violation of these rules shall be enforced as follows:
 - o **FIRST VIOLATION** Resident will receive a letter.
 - o **SECOND VIOLATION** One-week pool suspension
 - o **THIRD VIOLATION** Two-week pool suspension
